

DECISION No 1/2021

*on the rules for ensuring safe conditions of accommodation and stay in the Student Dormitory of the Krzysztof Penderecki Academy of Music in Krakow (AMKP) in connection with preventing, counteracting and combating COVID-19, of 25 June 2021.*

Acting pursuant to § 1 sec. 7 of Regulation No. 26/2020 of September 17, 2020 on the functioning of the Academy from October 1, 2020 in connection with preventing, counteracting and combating COVID-19, I hereby establish the following:

§1

In order to ensure safe accommodation and stay at the AMKP Student Dormitory (SD):

1. every person is obliged to disinfect their hands with a disinfectant directly at the entrance to the SR building,
2. students are accommodated in single and double rooms with access to a bathroom and a kitchenette, each,
3. the number of people using the common rooms (lecture halls, classrooms and practice rooms) is limited, allowing a minimum distance of 1.5 meters,
4. it is allowed to receive guests by AMKP students at the Student Dormitory (SD), providing that no more than 2 people who are not residents of the SD may be admitted in a given room,
5. guest rooms can be available with sanitary restrictions, in particular: disinfection of min. 2 x daily touch surfaces, wearing masks in common areas, entry of unregistered persons is prohibited,
6. it is absolutely necessary to avoid the formation of groups in common rooms, e.g. in corridors, in classrooms and practice rooms, in the laundry room or in the courtyard,
7. while staying in classrooms and practice rooms, follow the rules set out in generally applicable regulations: cover the mouth and at night, unless the specific nature of the classes requires that the mouth and nose are exposed, keep a distance of 1.5 m,
8. eating in the classrooms and practice rooms is forbidden,
9. instructions for washing and disinfecting hands are posted in bathrooms, and telephone numbers for the sanitary and epidemiological station and medical services are posted on notice boards.

§2

If COVID-19 infection is suspected:

1. Each student or employee of AMKP is obliged to report any symptoms suggesting COVID-19 infection.

3. [refers to SD employees]
4. in the event of symptoms suggesting COVID-19 infection of a SD resident, the person is instructed to report to the nearest infectious disease ward as soon as possible for consultation with a doctor, by going there by own transport or by informing 999 or 112; the person waits for transport in a guest room, where it is possible to temporarily isolate him from other people, the SD manager notifies the poviatsanitary and epidemiological station and strictly adheres to the instructions and orders issued,
5. The SD manager notifies the poviatsanitary and epidemiological station and strictly adheres to the issued instructions and orders, determines the area in which the potentially sick employee / SD resident moved and stayed, the cleaning staff cleans the area and disinfects the touch surfaces (door handles, handrails, handles).

6. The SD manager sets up a list of people (if possible) present at the same time in parts / parts of the building where the SD employee / resident was staying and applies the guidelines of the Chief Sanitary Inspector relating to people who had contact with the infected,
7. The SD manager is responsible for supervising compliance with the sanitary regime in SD, providing equipment and disinfectants, and monitoring daily cleaning works, including monitoring the cleanliness of rooms, with particular emphasis on supervising the ongoing disinfection of touch surfaces - elevators, handrails, handles, doors, switches, handles, table tops in reception areas, offices, classrooms and practice rooms.

### §3

1. Entering the SD for the purpose of accommodation is tantamount to confirming that a given person meets the conditions for safe accommodation, i.e. that they do not show any disease symptoms indicating a contagious disease, are not under quarantine or isolation at home and are not staying with the person under quarantine. or isolation at home and to the best of their knowledge, they had no contact with a person infected with the SARS-CoV-2 virus during the 10 days prior to accommodation.
2. Each person accommodated in SD is fully responsible for non-compliance with the rules of sanitary safety, including criminal liability.

### §4

1. The decision comes into force on the day of its signing.
